Policy purpose

The purpose of this policy is to establish OK a.m.b.a.'s (OK) commitments and approach to climate, energy, environmental impact, and resource use. The policy ensures a structured and unified direction for efforts to reduce climate and environmental impact, promote optimal energy use, and minimize resource consumption.

Policy scope

The policy applies to all employees at OK and covers all OK's activities in the operation and development of the company, as well as the impact of our products and services.

Policy information

OK aims to be a driving force in the transition of society toward future energy and mobility solutions, in cooperation with our customers, suppliers, shareholders, and other stakeholders.

OK is committed to working towards:

Climate impact and energy consumption

- Monitor and reduce greenhouse gas emissions from our own activities and in our value chains, so that we can contribute to achieving the Paris Agreement.
- Support the transition of the transport sector through the expansion of EV charging stations and biofuels.
- Increase the share of renewable energy sources in our products and services.
- Implement energy-efficient technologies in our products, facilities, and business operations.

- Develop solutions to increase energy efficiency for both business customers and private customers.
- Invest in technologies and partnerships that promote low-energy solutions and/or reduce CO₂ emissions.
- Report transparently on OK's climate targets and focus areas in accordance with national and international standards.

Environmental impact

- Minimize the environmental impact from all our own activities.
- Prevent pollution by integrating environmental considerations in relevant decision-making processes as well as in procurement of products, materials and services where possible.
- Comply with all applicable environmental laws, regulatory requirements, and other obligations.
- Identify and assess environmental impacts from our products and services in a life cycle perspective.

Resource consumption

- Promote the circular economy and resource efficiency in our value chains.
- Minimise our waste generation and resource consumption by integrating resource considerations in relevant decision-making processes, as well as in procurement of products, materials and services where possible.

Collaboration & implementation

- Involve cooperative members, suppliers, customers, and other relevant stakeholders in the transition through dialogue, counselling, and knowledge sharing.
- Establish and maintain measurable targets to ensure continuous improvements in all mentioned areas.
- Strengthen relevant competencies among employees through continuous dialogue and training.
- Collaborate with authorities, suppliers, customers, shareholders, and other stakeholders on climate and environmental improvements as well as new innovative solutions.

- Integrate relevant climate and environment-related risks and opportunities in OK's strategic planning, investments, and decision-making processes.

Communication and training

OK's employees and managers are continuously informed of and trained in this policy as needed.
